Denmark will be on the UN Security Council in 2025-2026. Hence, your task will also be to ensure Denmark understands Tanzania's position on regional issues brought up in the UN Security Council.

• Build strong local networks and ensure regular outreach to relevant actors based on the Embassy's priorities, incl. regional security.



- Prepare written analysis and reports on regional security, and political and social development of relevance to Danish policy priorities.
- Participation in relevant working groups and coordination forums
- Manage smaller partnerships with think tanks
- Drive a continued dialogue with Danish and Tanzanian researchers and think tanks.

### About you, candidate qualifications and requirements

You have a passion for local and global development. You understand the political dynamics and are able to analyse and distill your knowledge to communicate key matters in a clear manner.

You are self-driven, ambitious and curious, and think out of the box when assessing mutual Danish-Tanzanian interests. You have an open mind and are interested in learning and supporting colleagues for a smooth running of the Embassy.

- Minimum a Bachelor's degree or equivalent in a related field (i.e. political science, economics, journalism or similar)
- At least 5 years of professional experience in the field
- Documented experience of working in similar/relevant positions
- Extensive knowledge of Tanzanian and regional political developments.
- Excellent communication skills in English and Kiswahili. A written case will be part of the recruitment process.
- High work ethic, self-motivation and flexibility to adapt to changing priorities.
- Ability to work independently as well as part of a team.
